*In 2016 the refugee crisis has affected 65 million people worldwide, of which – according to the UN Refugee Agency - only half a million could return to their homeland. #### Activities realized so far:

The project's team on IO1 created a guide presenting a methodological framework that can be used to assess and improve upon current strategies and to plan future interventions. The publication "**Challenges for Refugee Students & Strategies to Overcome them**" presents critical lessons learned and experiences and recommendations from European universities and the consortium. The publication takes the perspective of a central university administration, and addresses language issues from this point of view. Linguistic issues are constantly addressed throughout the publication as are language courses themselves. Remedial courses or preparatory courses are also one of the main points of discussion throughout the publication.

Furthermore the publication discusses current initiatives across Europe and builds upon their experiences to remedy the pitfalls that have been revealed by the current initiatives. The general framework for analysis is presented in a detailed fashion in the publication as a holistic and wide-array of best practices that target the challenges presented. IO1 material will soon be available with an open access on S.U.C.RE.'s website.

The initial project activities and objectives of the IO2 are now beginning; the bulk of work for IO2 is set to take place during the second project year. Intensive work on IO2 has begun after the multiplier event in Cologne, Germany, Sept. 2017.

### Intellectual Output 3:

Institutional Support for Refugee Scholars in Higher Education

#### Activities realized so far:

The planned project activities have been carried out according to plan. VU Amsterdam has sent out an on-line questionnaire to host institutions in Germany; The Netherlands; Belgium/ Flanders, France and Iceland, and to country coordinators / representatives in UK, Norway, Sweden, Finland, Canada, USA, Ireland and Switzerland (potential number of target institutions is at least 150). The team of the IO3 has already received 60 responses and 48 institutions are currently hosting 87 scholars. The University of Cologne is drafting a questionnaire on scholars at risk and refugee scholars.

### Intellectual Output 4:

Psychosocial Support through Communities' Engagement & Mobilization

#### Activities realized so far:

The IO4 team identified potential participants: NGOs' professionals working in the field, Refugee Education Coordinators (REC) from the Greek Ministry of Education, young refugees, etc. The IO4 team has also visited the camp of Diavata and has attended and/or actively participated in conferences and meetings regarding refugee education, protection and integration issues organized by NGOs. The team composed a focus group interview guide for NGO workers and another for refugees along with respective consent forms. These forms were sent to all partners. Six focus groups have been organized so far as well as a number of interviews with professionals from 10 NGOs. Also, 2 more focus groups were conducted with REC. The total sample consisted of 31 participants, 25 women and 6 men. Preliminary (thematic) analysis of the data has been also implemented. The IO4 team is now conducting desk research

Alexandros Triantafyllidis presented the project at the Utrecht Network – Annual General Meeting where important networking was achieved with co-operating European Universities (27<sup>th</sup> of April).

Eleni Koutsouraki from the Greek Council for Refugees presented the activities of S.U.C.RE. during the Dimensions of the "refugee issue and of the humanitarian crisis" Conference (3<sup>rd</sup> of April).

**Intellectual Output 5:**

Supporting refugees on Health and Law issues

**Activities realized so far:**

The resulting course material on legal, medical and social security support has been completed, alongside with the relevant notes. The material regarding legal issues consists of five parts. The first part gives definitions, whereas the second part focuses on the refugee status determination. The third part stresses the importance of the normal and special asylum procedures, the fourth part deals with the minimum standards of reception conditions; finally the fifth part talks about the administrative detention of asylum seekers. The bibliography and useful educational material, such as relevant case-law and legislative texts are also available. Regarding medical support, the educational material is divided into the following topics: aim of first aid, stages of action, resuscitation position, and handling as well as how to deal with fainting, electrocution, bleeding, burn and choking. Information on personal hygiene up-keeping and disease prevention measures for people in close quarters is also included. Furthermore, IO5 deals with the social security issues like the conditions of access to health in AIDA (Asylum Information Database) countries. Other topics include issues of pension of uninsured adults, the recognized social rights of refugees, issues of social benefits and allowance, etc. IO5 training material will soon be available in AUTH's e-learning platform and will be also available with an open access on S.U.C.RE.'s website.

**InfoMigrants is a news and information site for migrants to counter misinformation at every point of their journey:** in their country of origin, along the route, or in the places where they hope to start a new life. InfoMigrants is available in three languages: French, Arabic and English. Where to start if you're a refugee seeking advice in Sweden, Germany, Italy or Greece? What is a great first stop if you're a refugee seeking help in Sweden, Germany, Italy or Greece? InfoMigrants collected information on organizations that might be helpful. There are dozens, if not hundreds of organizations, that offer help to refugees in the EU. But many charities are highly specialized or only active in some regions. InfoMigrants looked at what nationwide refugee charities could be a helpful jumping-off point for refugees seeking help. We looked at four countries with a high refugee population - Germany, Greece, Italy, and Sweden.

### Council of Europe: First European Qualifications Passports for Refugees issued in Greece:

The first European Qualifications Passports for Refugees were issued in Athens. This certificate will help refugees who had to flee their countries to continue with their studies or work. Nineteen candidate refugees went through individual interviews with experienced evaluators to ascertain their qualifications in the absence of supporting documentation. Fourteen were issued the European Qualifications Passport.
